OPENING ADDRESS - Yusuf Mayet, Senior Manager: Investment Promotion, Facilitation and Retention, City of Ekurhuleni Aim: Overview of mid to long term plans that the city is pursuing to drive economic development including renewable energy projects and the airport

- Active engagement is required with government at all levels to include focus areas; Energy, Water, Waste, Safety and Security.
- Industry noted a greater need to counter the lack of municipal service delivery, to sustain factory operations.
- Municipal infrastructure is slowing processes down.
- Business stands ready to engage while noting the need for policy certainty and consistency in outcomes to motivate ongoing investment in operations.

- Main area of focus Springs JVA Substation.
- Crime noted as highest priority. Improvement in cable theft incidents was an example of collaborations across municipal, community and industry stakeholders.

To prioritise and implement critical electricity and water infrastructure projects with an industry hub focus.

Springs MOU has been drafted by industry and shared with the CoE for consideration.
